SECTION II – FACILITY PROFILE

- 1. The Springfield Metropolitan Exposition & Auditorium Authority (SMEAA) was created pursuant to the Illinois Compiled Statutes to oversee the Bank of Springfield Center (formerly Prairie Capital Convention Center). SMEAA is classified as a municipality with taxing powers and is governed by an elected board, consisting of eleven members.
- 2. The Bank of Springfield Center is an approximately 65,000 square foot, multi-purpose facility. The building broke ground for construction in 1975, held a grand opening in November 1979, and completed an \$18 million renovation in 2013.
- **3.** The SMEAA Board will contract for rigging equipment.

SECTION III - CRITERIA FOR EVALUATION OF RESPONSES

The Bank of Springfield Center will evaluate the responses to this RFP based on the submitter's ability to:

- Meet the requirements described in this RFP as evidenced by the RFP response.
- Provide evidence of qualifications and technical expertise to produce theatrical curtains for the Bank of Springfield Center.
- Demonstrate expertise as evidenced by similar installed rigging equipment.
- Provide a superior level of customer service and support.

Provide a rigging equipment proposal that includes:

- 2. 4-12" x 12" Heavy Duty Box Truss -8' Length
- 3. 18 10' Schedule 40 Aluminum Pipe

Each pipe to have 3/8 Eyes and S hooks, on 12" centers (for hanging drapery) Pipe needs to be mounted in each 10' truss.

4. 4 – 8' Schedule 40 Aluminum Pipe Each pipe to have 3/8 Eyes and S hooks, on 12" centers (for hanging drapery) Pipe needs to be mounted in each 8'truss.

- 16. Quote must include all labor, riggers, and supervisors for installation.
- 17. Quote must include any machinery needed for installation, such as aerial lifts.
- 18. Quote shall include the installation of chain motors, rigging equipment, Installation of electrical boxes, etc.(Electrical contractor will install conduits and pull required wire).
- 19. Local electrical contractor will run all conduits and pull wire for system installation. Please provide wiring diagram for electrical contractor to use for electrical quote.
- 20. Include submittal drawing of each piece of equipment.
- 21. Include a system wiring diagram for the distribution and control package.
- 22. Include a second option for west end rigging baton with no angles, only runs straight from north to south for curtains.

SECTION VI – ADDITIONAL NOTICES

1. The Illinois Department of Labor prevailing rate of wages for Sangamon County is required for each craft or type of worker needed to execute the contract.

2. Responsible Bidder: Any entity submitting a bid shall include a complete, accurate, and truthful listing and description of all citations, complaints, summons, decisions, determinations, judgments, or other allegations or findings of any violation of state or federal laws, which protect health, safety, or welfare of workers, including but not limited to OSHA, FMLA, FLSA,

ADA, ADEA, NLRA, the Federal Civil Rights Act, the Illinois Human Rights Act, the Illinois Wage and Hour Law, and the Prevailing Wage Act filed against it or any entity with whom it is submitting the bid.

3. If the lowest bidding local vendor is a responsible bidder and the lower bidders are not local vendors and if the local vendor's bid is higher than the nonlocal by no more than five (5) percent, then that local vendor shall be considered the local responsible bidder.
